## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, APPROVING THE CITY OF RIVERSIDE TO RECEIVE THE DEPARTMENT OF CALIFORNIA HIGHWAY PATROL'S 2021/2022 CANNABIS TAX FUND GRANT PROGRAM AWARD IN THE AMOUNT OF \$95,108.22; AND AUTHORIZING THE EXECUTION OF NECESSARY GRANT DOCUMENTS BY THE CITY MANAGER OR HIS DESIGNEE.
