RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated June 12, 2018 ("Agreement"), for Temporary Employment Services – RFP No. 1726 ("Project"); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement dated June 25, 2019 ("First Amendment"), for Temporary Employment Services – RFP No. 1726; and

WHEREAS, the City and Consultant entered into that certain Second Amendment to Professional Consultant Services Agreement dated July 29, 2020 ("Second Amendment"), for Temporary Employment Services – RFP No. 1726; and

WHEREAS, the City has been satisfied with Consultant's performance under the Agreement and desires to have Consultant continue providing the services referenced in that Agreement; and

WHEREAS, the Agreement is currently set to expire on June 30, 2021; and

WHEREAS, the City and Consultant desire to amend the Agreement to extend the term for one (1) additional year to June 30, 2022.

NOW, THEREFORE, incorporating the recitals, which are incorporated herein by this reference, City and Consultant agree as follows:

1. Section 2 ("Term") of the Agreement is hereby amended to read as follows: "2. Term. This Agreement shall be effective on the date first written above and shall remain in effect until June 30, 2022, with the option of two one-year renewals after June 30, 2022, upon mutual consent of the parties, unless otherwise terminated pursuant to the provisions herein."

2. All other terms and conditions of the Agreement, First Amendment and Second Amendment between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
