4	SCHOOL DISTRICT TO PROVIDE LUNCHES FOR THE 2021 SUMMER				
5	FOOD PROGRAM; AND (2) AUTHORIZING THE PURCHASING MANAGER TO ISSUE A PURCHASE ORDER IN AN AMOUNT NOT TO EXCEED \$158,400.00 FOR SUCH PROCUREMENT.

7	WHEREAS, the City has contracted with the Riverside Unified School District				
8	("RUSD") for the past eighteen years to provide free lunches to economically disadvantaged				
9	children at park sites that are directly supervised by the Parks, Recreation and Community				
10	Services Department ("PRCSD") through the Summer Lunch Program; and				
11	WHEREAS, the Summer Lunch Program has been funded by grants from the California				
12	Department of Education, and PRCSD is submitting a new application for a grant to cover the				
13	2021 Summer Lunch Program; and				
14	WHEREAS, ten park sites have qualified under Federal Guidelines for the Summer				
15	Lunch Program; and				
16	WHEREAS, the City and RUSD have a positive working relationship and have strived to				
17	maintain open communication and improve the Summer Lunch Program each year; and				
18	WHEREAS, in 2019, the Summer Lunch Program provided excellent tasting meals,				
19	service, a high number of participants, and revenue to cover food labor costs for the program;				
20	and				
21	WHEREAS, PRCSD would not be able to provide funding for the Summer Lunch				
22	Program without the grant from the California Department of Education; and				
23	WHEREAS, the Federal Guidelines for the Summer Lunch Program allow participating				
24	agencies to contract with a local school district for the preparation of meals without going				
25	through the competitive bidding process; and				
26	WHEREAS, given the past working relationship with RUSD and the past success of the				
27	Summer Lunch Program, staff believes that continuing to contract with RUSD is in the City's				
28	best interest because the price, quality of meals and service provided by RUSD are outstanding;
