

**THIRD AMENDMENT TO AGREEMENT FOR LANDSCAPE MAINTENANCE
SERVICES FOR SOUTH QUADRANT PARKWAYS AND MEDIANS**

THIS THIRD AMENDMENT TO AGREEMENT FOR LANDSCAPE MAINTENANCE SERVICES FOR SOUTH QUADRANT PARKWAYS AND MEDIANS ("Third Amendment") is made and entered into this ____ day of _____, 2020, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and MARIPOSA LANDSCAPES, INC., a California corporation ("Contractor"), with reference to the following facts:

RECITALS

A. On August 9, 2016, City and Contractor entered into an Agreement for Landscape Maintenance Services for South Quadrant Parkways and Medians ("Agreement") for three years, through June 30, 2019, with an option to extend for additional one (1) year periods, not to exceed a total of two (2) additional years;

B. On May 6, 2020 City and Contractor extended the term of the Agreement for an additional one-year term, through June 30, 2021;

C. City and Contractor desire to extend the term of the Agreement for an additional one-year term, through June 30, 2022.

NOW THEREFORE in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Contractor mutually agree as follows:

1. Section 2, "Term", is amended to extend the Term of the Agreement up to, and including, June 30, 2022.

2. For the extended term of the Agreement, City shall pay Contractor for the performance of the services a Contract Price of Seven Hundred Forty-Seven Thousand Nine Hundred Twenty-Seven Dollars and Thirty-Three Cents (\$747,927.33).

3. All terms and conditions of the Agreement and its amendments not inconsistent herewith shall remain in full force and effect, and are hereby incorporated by reference into this Third Amendment as though set forth in full herein.
