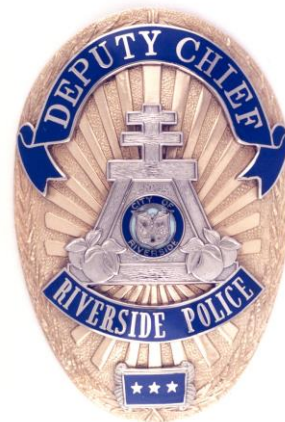

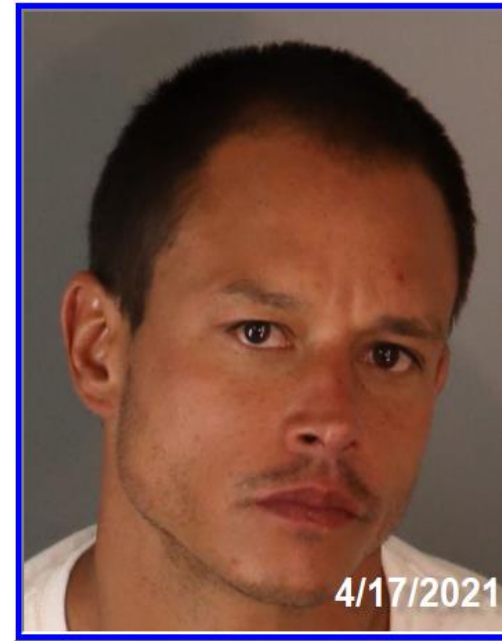

34 Years old



SUSPECT

- Criminal history consists of the following:
 - Narcotics Possession, Public Intoxication, Resisting Arrest, Violation of a Restraining Order, Under the Influence of Narcotics, Trespassing, Vandalism, Vehicle Theft, and Possession of Stolen Property.
- Active Felony Warrant – Vehicle Theft \$10,000
- Active Misdemeanor Warrant – Possession of Stolen Property \$10,000
- Per family, Marquez was addicted to meth & officially became homeless in March of 2020 after a breakup with the mother of his child



OVERVIEW

- The Public Safety Engagement Team (PSET) meets every morning at the beginning of their shift to discuss priorities for their day's activity.
- The morning of May 8, the team discussed several recent reports of transient activity around Magnolia and Elizabeth. Due the numerous reports, they prioritized that location as their first stop for the day.
- The PSET team for that day consisted of two RPD Police Officers, One Riverside City Code Enforcement Officer, One City-Net Case Manager, and One City-Net Social Worker.



TIMELINE

- 08:17:38** – Members of PSET depart City Hall to check the Elizabeth Street corridor
- 08:21:46** – Code enforcement officer leads the convoy & activates his amber lights upon arrival
- 08:21:58** – Suspect sees officers and begins to walk north in an apparent attempt to avoid them
- 08:22:04** – Officer #1 puts the unit in park & exits prompting the suspect to turn around & walk in the opposite direction
- 08:22:12** – Suspect turns around & acknowledges Officer #1 as he continues to walk away
- 08:22:16** – Suspect pulls a gun from his waistband, drops it to his side then raises it towards officers prompting the OIS
- 08:22:20** – Officer #1 broadcasts “Shots fired”



TIMELINE CONTINUED

08:29:00 – Officers #1 and #2 are pulled from the arrest team

08:30:49 – Arrest team moves up and separates the suspect from the gun

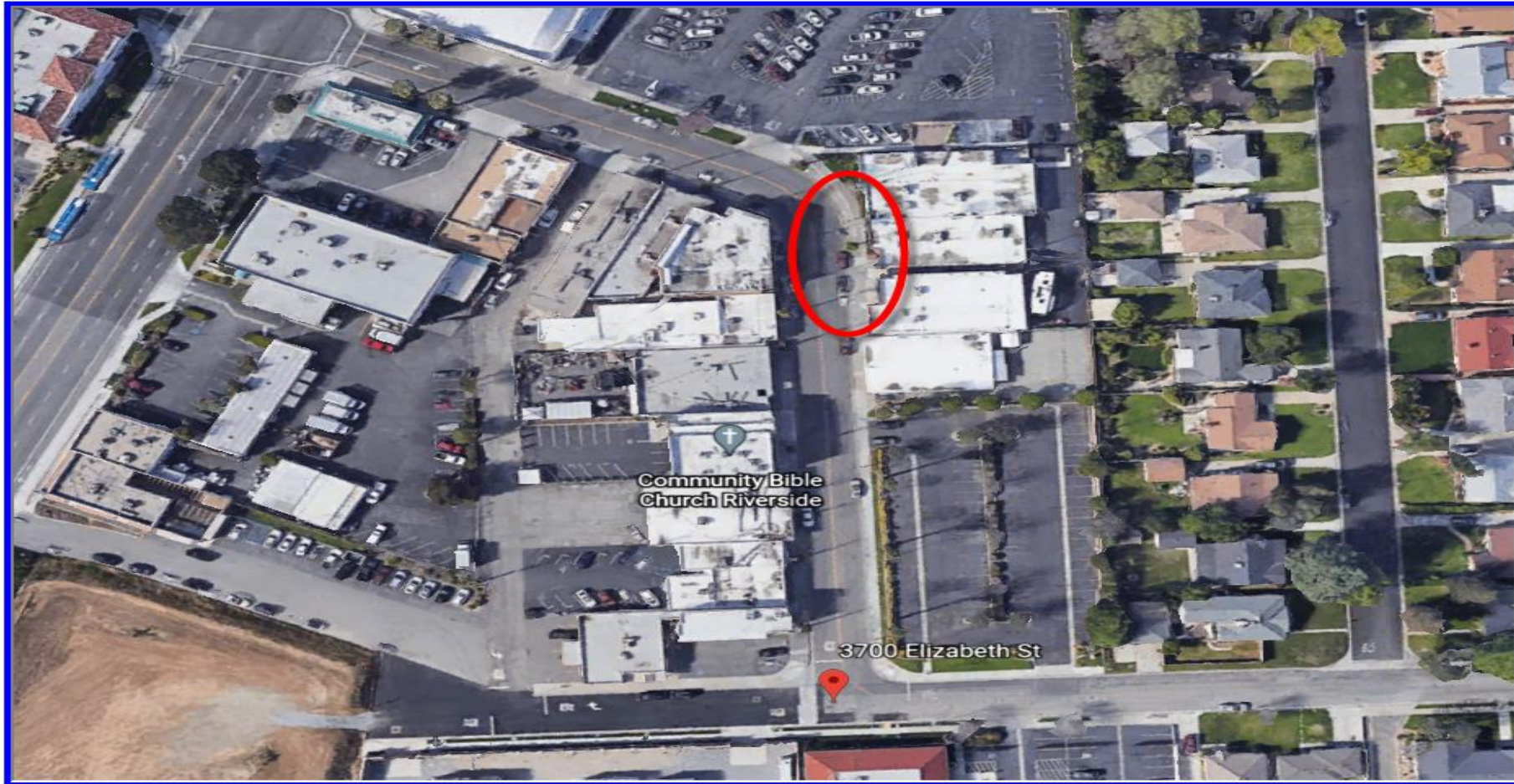
08:33:12 – RFD arrives and begins treating the suspect

08:35:02 – AMR transports to Riverside Community Hospital

09:01:00 – Suspect is pronounced deceased by physician.
