

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO REMOVE A TIMED NO
5 STOPPING ZONE AND REVISE A NO STOPPING AT ALL TIMES ZONE
6 ON CANYON CREST DRIVE.

7 WHEREAS, the Public Works Department received a request from the president of The
8 Crest Homeowners Association which serves the townhomes located at 5050 Canyon Crest Drive
9 to consider allowing parking at the frontage of their property at all times rather than the current
10 conditions which allow parking only between 7:00 p.m. and 7:00 a.m. Monday through Friday
11 and all day on weekends; and

12 WHEREAS, a current Public Works Active Transportation Program (ATP) Cycle II grant
13 funded project which included installation of bike lanes on a portion of Canyon Crest Drive was
14 underway and further evaluation allowed staff to develop an alternate design for the portion of the
15 bike lane on the east side adjacent to the area between Crest Park Circle (North) and Crest Park
16 Circle (South) along a portion of the frontage of 5050 Canyon Crest Drive to provide curbside
17 parking with adjacent bike lane allowing for parking at all times within this specific area only;
18 and

19 WHEREAS, the small segments at the frontage of 5050 Canyon Crest Drive north of Crest
20 Park Circle (North) and south of Crest Park Circle (South) could not accommodate curbside
21 parking and thus require revision of the existing No Stopping At All times zone on a segment of
22 Canyon Crest Drive to include these areas; and

23 WHEREAS, signage for the project has been installed and the prior “No Stopping 7am to
24 7pm Mon-Fri except holidays” signs at the frontage of the townhome complex as 5050 Canyon
25 Crest Drive have been removed; and

26 WHEREAS, the changes implemented will better serve the needs of the townhome
27 residents and their guests by allowing parking at all times between the property driveways while
28 providing a dedicated adjacent bike lane to separate cyclists from parked vehicles and the travel
lanes; and

1 WHEREAS, formal removal of the Timed No Stopping zone and revision of the
2 existing No Stopping At All Times zone are proposed to accurately reflect the current parking
3 conditions at the frontage of 5050 Canyon Crest Drive; and

4 WHEREAS, on April 7, 2021, the Transportation Board unanimously to recommend the
5 proposed removal of the existing Timed No Stopping zone on the east side of Canyon Crest Drive
6 at the frontage of 5050 Canyon Crest Drive and revision of the boundaries of the existing No
7 Stopping At All Times zone on a segment of Canyon Crest Drive.

8 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
9 California, as follows:

10 Section 1: The recitals set forth above are incorporated herein by reference.

11 Section 2: That the Master Parking Schedule is hereby amended by 1) removing a No
12 Stopping between the hours of 7:00 a.m. to 7:00 p.m. Monday through Friday, except holidays”
13 zone on the east side of Canyon Crest Drive at the frontage of 5050 Canyon Crest Drive; and 2)
14 revising the boundaries of the existing “No Stopping At All Times” zone from “Both sides of
15 Canyon Crest Drive from Martin Luther King Boulevard to Central Avenue except the frontage of
16 5050 Canyon Crest Drive” to “Both sides of Canyon Crest Drive from Martin Luther King
17 Boulevard to Central Avenue except the area on the east side between Crest Park Circle (North)
18 and Crest Park Circle (South).”

19 Section 3: That the provisions of this resolution shall be operative only when signs are
20 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
21 limitations or prohibitions herein established.

22 Section 4: The provisions of this amendment shall be operative as of the date of adoption
23 of this resolution.
