PRSCD Director Cruz reported numbers are trending down, the city could possibly move from purple tier to red tier that's positive news with more people getting vaccines quite a bit has

opened, a good resource is vaccinefinder.org. He noted various places offering shots, Rite Aid, Walgreens, Doctor Offices. City worked with the county to Mobile Unit locations Goeske was Sunday, March 14, Dales Senior Center Monday, March 15, La Sierra Senior Center, Thursday, March 18 and Casa Blanca Library Saturday, March 20. Director Cruz stated we are moving in the right direction; we are still at serious level. Chair Tavaglione shared she follows City and County of Riverside websites for information and thinks they are doing an excellent job reporting. Commissioner Van Vegten asked if we know how many people have been vaccinated? Commissioner Jimenez stated you can get the information on the public health website; people can also call the county hospital for an appointment for vaccination. Director Cruz reported at the Riverside Council meeting Tuesday, March 16, Mark Annas the EOC Manager provides update to council at each council meeting at the 1pm meeting.
