Hunter V. Plascencia Response

Background:

After the election I met with the City Manager Al Zelinka to discuss the on boarding process. Like with any new job the first thing you do is order business cards. Al reported that his secretary would be in touch with my assistant to start the process. I explained that I was interested in putting the labor bug on my council card. Al explained that at the end of the December 3, 2019, meeting, I could request to put it on the agenda for the following City Council Meeting. At the December 3, 2019, City Council meeting, I asked that staff put the labor bug on the next council agenda (Voice Clip Attachment 1). When the next meeting agenda was posted, I saw that my requested agenda item was not on there. I spoke to Al an asked him why it wasn't on there and, I don't remember what his response was. However, I do remember Al outlining how we could put it on the December 17, 2019, agenda. I expressed to AI that my assistant and I were eager to get out in to the community to introduce ourselves and pass out our business cards so that the residence could get to know us and be able to contact us. I was told that staff would work on the report, and that they would contact me for my signature and that they would need another council member's signature as a part of the Sunshine Ordinance (Attachment 5. Sunshine Ordinance 459). We met the requirement for the Sunshine Ordinance by getting two council members signatures. I don't understand how I violated the Sunshine Ordinance as we met the guidelines as outlined by Section D). 2.a, in the Sunshine Ordinance.

I did not prepare the staff report, and I am not sure if it was the city manager's office or the city clerk's office who prepared it. I am not on the agenda setting committee, so I do not know exactly who chose to put it on the calendar during the day. I believe that I followed all rules and regulations outlined by the City Charter. 

13	Section 60: Section 18.180.050(A), (B)(1) and (C) of the Riverside Municipal Code is

15	"A. The period within which the exercise of a map or permit must occur may be extended by
16	the Community & Economic Development Director. An application for extension shall be filed prior to expiration of the permit along with appropriate fees and necessary submittal materials
17	pursuant to Chapter 18.150 General Application Processing Procedures.
18	B. Tentative maps.
19	1. Tentative tract, parcel, vesting, and reversion acreage, condominium, and environmental
20	subdivision maps. The Community & Economic Development Director may extend the life of a tentative map beyond the initial 36 month approval by up to six additional years, or as may
21	be further specified in Section 66452.6 (e) of the Government Code of the State of California.
22	• • •
23	C. Granting of stay. The period of time specified in subdivision B, including any extension
24	granted by the Community & Economic Development Director, shall not include the period of time during which a lawsuit involving the approval or conditional approval of the tentative
25	map is or was pending in a court of competent jurisdiction, if the stay of the time period is
26	approved by the Community & Economic Development Director. After service of the initial petition or complaint in the lawsuit upon the Community & Economic Development Director,
27	the subdivider may apply for a stay following the same procedures in subdivision A. Within 40 days after receiving the application, the Community & Economic Development Director
28	shall either stay the time period for up to five years or deny the requested stay.
