AFFORDABILITY COVENANTS

Mechanism used to preserve affordable rental housing through a deed restriction or covenant which imposes maximum rents and tenant eligibility for a period of time

CITY OF RIVERSIDE

- 52 residential properties with affordability housing covenants
 - 3,157 rental housing units
 - Expiration: 2020 to 2076
- Housing Authority staff will reach out to property owners prior to the expiration of covenants to discuss refinance options
- State of California May Revise Budget: One-time allocation of \$300 million from the federal American Rescue Plan Act (ARPA)
