

**FOURTH AMENDMENT TO
AGREEMENT FOR GENERAL LANDSCAPE MAINTENANCE SERVICES FOR
VARIOUS PUBLIC UTILITIES PROPERTIES**

THIS FOURTH AMENDMENT TO AGREEMENT FOR GENERAL LANDSCAPE MAINTENANCE SERVICES FOR VARIOUS PUBLIC UTILITIES PROPERTIES (“Fourth Amendment”) is made and entered into this ____ day of _____, 2021 (“Effective Date”), by and between the CITY OF RIVERSIDE (“City”), a California charter city and municipal corporation, and MARIPOSA LANDSCAPES, INC., a California corporation (“Contractor”).

RECITALS

WHEREAS, the City and Contractor entered into that certain Agreement for General Landscape Maintenance Services for Various Public Utilities Properties (“Agreement”) dated July 27, 2016; and

WHEREAS, the City and Contractor entered into that certain First Amendment to Agreement for General Landscape Maintenance Services for Various Public Utilities Properties (“First Amendment”) dated March 8, 2018; and

WHEREAS, the City and Contractor entered into that certain Second Amendment to Agreement for General Landscape and Maintenance Services for Various Public Utilities Properties (“Second Amendment”) dated February 22, 2019; and

WHEREAS, the City and Contractor entered into that certain Third Amendment to Agreement for General Landscape and Maintenance Services for Various Public Utilities Properties (“Third Amendment”) dated March 5, 2020; and

WHEREAS, the City and Contractor desire to amend the Agreement to extend the expiration date of Agreement from July 1, 2021, to June 30, 2022, in the amount not to exceed Two Hundred Fifty Thousand Seven Hundred and Forty Three Hundred Dollars (\$250,743.00) per year, for services rendered during the extended term.

NOW THEREFORE, in consideration of the foregoing recitals, which are incorporated herein by this reference, City and Contractor agree as follows:

1. The term of the Agreement is extended from July 1, 2021, to June 30, 2022.
2. Compensation during the extended one-year term of the Agreement shall not exceed Two Hundred Fifty Thousand Seven Hundred and Forty Three Hundred Dollars (\$250,743.00), paid in accordance with Exhibit "A," attached hereto and incorporated herein by this reference.




This letter will serve as an acceptance to extend our current landscape maintenance contract agreement RFP #1611 for an additional year ending June 30th, 2022.

Per the existing agreement RFP #1611, Mariposa Landscape Inc., proposes to maintain the level of service at the current compensation rate of \$20,895.25 per month for a NTE total of \$250,743.00 for fiscal year 2021/2022. If granted such extension will become effective July 1st, 2021.

As is the case during the current fiscal year, an additional \$16,776.60 per year (\$1398.05) per month) will be requested if the City decides to continue to use Glyphosate substitute(s) for a combined monthly total of \$22,293.30 and a yearly combined total of \$267,519.60. The difference in the substitute cost reflects the increase to the materials cost for 2021.

I would like to take this opportunity to thank you for allowing Mariposa Landscape Inc. to be the provider of quality landscape maintenance services to the City of Riverside, Public Utilities Agency. We look forward to a very successful year.
