

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE ON
4 BEHALF OF THE CITY OF RIVERSIDE ALL NECESSARY CONTRACTS,
5 PAYMENT REQUESTS, AGREEMENTS AND AMENDMENTS IN THE
6 PROCESS OF APPLYING FOR AND SECURING FUNDS UNDER THE
7 CLEAN MOBILITY OPTIONS VOUCHER PILOT PROGRAM

8 WHEREAS, the City of Riverside, as Lead Applicant, submitted a Mobility Project Voucher
9 Application on October 20, 2020, for the Clean Mobility Options Voucher Pilot Program (CMO).
10 The application submitted was for the Riverside Clean Air Car Share; and

11 WHEREAS, the City Council of the City of Riverside is eligible to receive funding through
12 CMO, a statewide initiative funded by California Climate Investments, and administered by
13 California Air Resource Board's Program Administrator team to provide funding for zero-emission
14 shared mobility options to under-resourced communities in California;

15 WHEREAS, the City of Riverside will comply with the requirements of the CMO program;
16 will accept the CMO voucher funds; and will allocate the grant amount of \$1,000,000, including any
17 Community Resource Contributions, committed to the project in the CMO application and as
18 amended by the Program Administrator and awardee;

19 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
20 California, as follows:

21 Section 1: The City Manager, or its designee, is hereby authorized and empowered to
22 execute on behalf of the City all necessary documents, including but not limited to applications,
23 payment requests, approval of CMO voucher funds, agreements and amendments thereto, necessary
24 to secure grant funds and to implement the approved grant project, reiterate CMO program
25 commitment, and compliance with CMO program requirements to the CMP Program Administrator
26 Team.
