2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, CREATING A ROSTER OF MUNICIPAL PARKING  
4 FACILITIES & GROUND LEASES FOR PARKING; AND REPEALING  
5 RESOLUTION NO. 23226.

6 WHEREAS, on September 19, 2017, the City Council adopted Resolution No. 23226 repealing  
7 prior resolutions establishing the City's Roster of Municipal Parking Facilities and Ground Leases for  
8 Parking ("Roster"); and

9 WHEREAS, the City desires to remove lots 39, 40, 44, 50 and 51 from the Roster and add a  
10 new lot for the Main Public Library as described on Exhibit "A" attached hereto; and

11 WHEREAS, the City further desires to repeal Resolutions No. 23226 in its entirety and adopt  
12 this Resolution creating an updated Roster.

13 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
14 California, as follows:

15 Section 1. The Roster, as set forth in Exhibit "A" attached hereto and incorporated herein  
16 by reference, is hereby adopted as the official list of the City's Municipal Parking Facilities and  
17 Ground Leases for Parking.

18 Section 2: Resolution No. 23226 is hereby repealed in its entirety.

19 Section 3: The City Council desires to adopt this Resolution which shall provide an  
20 updated Roster.
