LLP TO APPROVED OUTSIDE ATTORNEY PANEL

## **ISSUE**:

The addition of the following law firms to the City's approved outside attorney panel: Wood Smith Henning & Berman LLP; Lozano Smith Attorneys at Law; and Slovak Baron Empey Murphey & Pinkney LLP.

# **RECOMMENDATION:**

That the City Council add the following law firms to the City's approved outside attorney panel:

- a. Wood Smith Henning & Berman LLP;
- b. Lozano Smith Attorneys at Law; and
- c. Slovak Baron Empey Murphey & Pinkney LLP.

#### **DISCUSSION:**

The City Attorney's Office has developed an in-house legal services team. However, there are times in which it is necessary to employ a panel firm to provide legal services, if for example, there is a conflict of interest or there are inadequate office resources due to unforeseen medical issues with staffing that require long leave periods. Because the City has been handling most of its litigation in-house for the last seven years, the City currently does not have many law firms on its approved panel who specialize in tort litigation. The City Attorney proposes to add the law firms of 1) Wood Smith Henning & Berman LLP ("WSHB"); 2) Lozano Smith Attorneys at Law; and 3) Slovak Baron Empey Murphey & Pinkney LLP ("SBEMP"). Having these firms added to our approved panel will enable the City Attorney's Office to have more options in the rare and unusual event the need arises to retain outside counsel.

WSHB is based in Southern California, with offices in Riverside, Rancho Cucamonga, Orange County, Glendale, and San Diego. They have extensive experience representing municipalities and public agencies in both litigation and administrative hearings. For example, they represent

law enforcement agencies, peace officers, school districts, school boards, individual schools, and municipalities. They have ABOTA trial lawyers who pursue innovative legal strategies, while respecting the bottom line for public entities. Their reputation is reflected in their clientele and their attorneys' frequent appearances as law school professors, lecturers, and panelists for programs sponsored by national, state and local bar associations and other professional groups. They have developed expertise in ADA compliance issues, tort litigation, personal injury including catastrophic injuries and deaths, employment, appellate work, construction, mold and water damage claims, and subrogation.

Lozano Smith Attorneys at Law is based in Northern California with offices in Los Angeles, Bakersfield and San Diego. Since 1988, Lozano Smith has represented numerous public agencies.
