

FIRST AMENDMENT TO
PROFESSIONAL CONSULTANT SERVICES AGREEMENT

THIS FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("First Amendment") is made and entered into this _____ day of _____, 2021, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and MBC AQUATIC SCIENCES, a California corporation ("Consultant"), with respect to the following:

RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated April 22, 2019 ("Agreement") for Toxicity Testing of Wastewater and Other Ambient Waters for the City of Riverside Regional Water Quality Control Plant ("Project").

WHEREAS, the City desires to extend the contract another two years.

WHEREAS, the City and Consultant desire to extend the term of the Agreement to June 30, 2023 for an additional amount of Thirty-Nine Thousand, Two Hundred Forty Dollars (\$39,240).

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

1. Section 2, Term, is hereby amended to extend the term of the Agreement an additional two years, to June 30, 2023.

2. Section 3, Compensation/Payment, is hereby amended to include an additional amount of Thirty-Nine Thousand Two Hundred Forty Dollars (\$39,240) for a revised total contract amount not to exceed Seventy-Four Thousand Forty Dollars (\$74,040) payable in accordance with Exhibit "B-1" attached hereto and incorporated herein.

3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.


