

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE ON  
4 BEHALF OF THE CITY OF RIVERSIDE, ALL NECESSARY APPLICATIONS,  
5 CONTRACTS, PAYMENT REQUESTS, AGREEMENTS AND AMENDMENTS  
6 IN THE PROCESS OF APPLYING FOR AND SECURING FUNDS UNDER THE  
7 DEPARTMENT OF RESOURCES RECYCLING AND RECOVERY  
8 (CALRECYCLE) USED OIL PAYMENT PROGRAM.

9 WHEREAS, pursuant to Public Resources Code section 48690, the Department of Resources  
10 Recycling and Recovery (CalRecycle), formerly known as the California Integrated Waste  
11 Management Board, has established the Used Oil Payment Program (OPP) to make payments to  
12 qualifying jurisdictions for implementation of their used oil programs; and

13 WHEREAS, in furtherance of this authority, CalRecycle is required to establish procedures  
14 governing the administration of the Used Oil Payment Program; and

15 WHEREAS, CalRecycle's procedures for administering the Used Oil Payment Program  
16 require among other things, an applicant's governing body to declare by resolution certain  
17 authorizations related to the administration of the Used Oil Payment Program; and

18 WHEREAS, the City of Riverside ("City") desires to establish and maintain a used oil  
19 collection program in accordance with CalRecycle's Used Oil Payment Program that encourages  
20 recycling and the appropriate disposal of used oil throughout the City; and

21 WHEREAS, the City, as an applicant for available funds under CalRecycle's Used Oil  
22 Payment Program, must enter into an agreement with the State of California for the establishment,  
23 implementation and maintenance of a used oil collection program within the City; and

24 WHEREAS, in order to establish, implement and maintain a used oil collection program  
25 within the City, it is necessary for the City to designate the City Manager, or his designee, to act on  
26 behalf of the City in all aspects of the application process to procure available funds through the  
27 CalRecycle's Used Oil Payment Program; and

28 WHEREAS, the City also desires to extend the City Manager's authority to include the  
authority to apply for and secure the available funds on behalf of the City available under  
CalRecycle's Used Oil Payment Program and carry out all other purposes in the application process  
administered by CalRecycle, which authority shall be valid from the date of adoption of this  
Resolution up to and including June 30, 2026.

1 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
2 California, as follows:

3 Section 1: The City Council of the City of Riverside does hereby authorize the submittal  
4 of Used Oil Payment Program application to CalRecycle.

5 Section 2: The City Manager of the City of Riverside, or his designee, is therefore  
6 authorized and empowered as the City's Signature Authority, to execute on behalf of the City all  
7 necessary documents, including but not limited to applications, contracts, payment requests,  
8 agreements and amendments thereto, for the purpose of satisfying the City's application process  
9 requirements and securing and/or accepting funds through CalRecycle for the establishment,  
10 implementation and maintenance of a used oil collection program within the City under the Used Oil  
11 Payment Program.

12 Section 3: The authority granted herein to the City Manager of the City shall be valid  
13 from the date of adoption of this Resolution until June 30, 2026.
