RECITALS

WHEREAS, on September 3, 2013, City and Consultant entered into a Professional Consultant Services Agreement for Locating Subsurface Facilities ("Agreement"), expiring on June 30, 2016; and

WHEREAS, on June 28, 2016, City and Consultant entered into a First Amendment to Professional Consultant Services Agreement for Locating Subsurface Facilities ("First Amendment"), expiring on June 30, 2018; and

WHEREAS, on September 17, 2018, City and Consultant entered into a Second Amendment to Professional Consultant Services Agreement for Locating Subsurface Facilities ("Second Amendment"), expiring on June 30, 2021;

WHEREAS, City has requested that Consultant continue to provide the services under the Agreement for an additional One Hundred Twenty (120) days, with additional compensation not to exceed Two Hundred and Thirty-Five Thousand Dollars (\$235,000) during the extended term of the agreement.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Consultant agree as follows:

- 1. The term of the Agreement is hereby extended by One Hundred Twenty (120) days, to October 30, 2021. Consultant shall continue to provide the Services identified in the Agreement during the extended term of the Agreement.
- 2. Compensation during the extended term of the Agreement shall not exceed Two Hundred and Thirty-Five Thousand Dollars (\$235,000), and shall be paid in accord with the Amended Compensation Schedule, attached hereto as Exhibit "A-3" and incorporated herein by reference.

3. All terms and conditions of the Agreement not inconsistent with this Third Amendment shall remain in full force and effect and are incorporated herein by this reference as if set forth in full.
