SUBJECT: SUMMARY OF SECURITY/INCIDENT REPORTS

ISSUE:

Receive a summary of security/incident reports from May, June and July 2021.

RECOMMENDATION:

That the Board of Library Trustees receive and file the summary of security/incident reports from May, June and July 2021.

BACKGROUND:

The Riverside Public Library has established Rules of Library Conduct Identified and Prohibited by the Riverside Municipal Code Section 9.75 for successful running of its facilities, to maintain an appropriate library environment, and to ensure customers enjoy their Library visits. Library employees, in consultation with their supervisor, are authorized to issue warning and exclusion notices for violations to the Rules of Library Conduct.

An itemized summary below provides a brief description of the incidents, warning and exclusion notices that occurred at all Riverside Public Library locations in May, June and July 2021.

6/3/21 Exclusion Notice to library user for 365 days until 6/3/22 for violating the

Rules of Library Conduct Rule 20 harassing or threatening library staff. *

6/10/21 Incident of individual arrested outside near the Community room. The

individual was sleeping on the ground by the Arcade earlier. The individual

was also seen down the street waiving a stick at people. *

6/17/21 Incident report of individual in the 1st floor arcade injecting something in the

arm and became violent and tried to use the needle as a dart towards the

Security Guard. *

6/16/21 Incident of individual entering the building while closed.

6/26/21 Incident of individual causing a disruption in the children's area and

removing zip ties from storytime-to-go kits. Exclusion notice issued for 30 days for violating the following Rules of Library Conduct: Rule 14 (Vandalizing, damaging library materials; Rule 20 (Harassing library staff and customers, and Rule 24 (Disturbing others after being verbally warned

to stop being disruptive).

7/1/21 Incident of an individual causing a disruption about having to use an

elevator to access the library.

7/3/21 Exclusion notice issued to individual for 30 days until August 3, 2021, for

violating the following Rules of Library Conduct: Rule 20 (Harassing or threatening library staff or customer; Rule 24 (Disturbing others after being verbally warned to stop yelling; and Rule 5 (Shirts and shoes or other

footwear are required at all times within the library building.

7/8/21 Exclusion notice issued to individual for 30 days commencing on July 8,

2021 for violating the following Rules of Library Conduct: Rule 14 (vandalizing, damaging or abusing library materials, equipment or facilities; Rule 20 (Harassing or threatening library staff or customer; Rule 24

(Disturbing others after being warned to stop); and Rule 22 (Maintain good

hygiene).

7/13/21 Incident of an individual's personal belonging that accidentally was dropped

from the 3rd floor entrance to the ground level.

7/14/21 Incident of individual vandalizing furniture and property.

7/14/21 Incident of three library customers that were in the public elevator for

approximately an hour. The Fire Department and elevator technician

immediately responded.

There were no incidents reported.

Orange Terrace

7/8/21 Exclusion notice issued to library user for 30 days after an oral warning was

given for violating the following Rules of Library Conduct: Rule 14 (Use of the library's facilities, materials, and furnishings as intended. Malicious damage and/or destruction of library materials or property); Rule 18 (Unreasonable us of restrooms, including laundering or bathing; and Rule 21 (Staring at, following or photographing library staff or customers).
