BACKGROUND

Resolution No. 23618 provides for the reorganization of Standing committee and regional organizational assignments with the following criteria:

- 1. Proceeding a municipal election;
- 2. Every standing committee is comprised of three members with each councilmember serving as a Chair, Vice Char, and Member of three committees, respectively;
- 3. Preferences of senior councilmembers shall be honored to the greatest extent possible; and
- 4. The Mayor's Nominating and Screening Committee (MNSC) refer recommendations to the City Council.
