Item 8 Architectural Design Services for the new City of Riverside SPC Jesus S. Duran Eastside Library

Library Director Christmas provide an update on the on the selection of a proposed new site and Request for Proposal 1934 for Architectural Design Services for the New City of Riverside SPC Jesus S. Duran Eastside Library. On July 28, 2021 Library and General Services staff met with the Architectural firm Cannon Design to begin the SPC Jesus S. Duran Eastside Library Phase 1 Design work possibilities at the Children's Health, Education, Enrichment and Resource (C.H.E.E.R.) Center located at Bobby Bonds Park. Key components will include engaging with project stakeholders, Board of Library Trustees, Parks, Recreation and Community Services through community meetings and the to determine preliminary building size, programming, spatial requirements, building layout and parking requirements for the proposed building including the proposed exterior event/entertainment/meeting plaza. Additionally, the architect will provide proposed Phase 2 project costs and schedule. Funding for Phase 2 project costs have not been identified but staff are seeking funding alternatives. Phase One Design should be substantially completed by the end of the calendar year 2021.

Costs associated with Phase 1 Design Services will be paid with Measure Z funds as approved by City Council on April 19, 2019. Sufficient funds in the amount of \$100,000 are available in the Eastside Library Project account 9907409-462050 Measure Z Fund 420.
