RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, ACTING IN ITS CAPACITY AS THE LEGISLATIVE BODY OF COMMUNITY FACILITIES DISTRICT NO. 2021-2 (RIVERPOINTE/PARK PLACE) OF THE CITY OF RIVERSIDE CERTIFYING THE RESULTS OF THE SEPTEMBER 7, 2021 SPECIAL TAX AND BOND ELECTIONS

WHEREAS, the City Council (the “City Council”) of the City of Riverside, California (the “City”), acting as the legislative body of Community Facilities District No. 2021-2 (Riverpointe/Park Place) of the City of Riverside (the “Community Facilities District”), called and duly held elections on September 7, 2021 within the boundaries of the Community Facilities District pursuant to Resolution Nos. _____ and _____ for the purpose of presenting to the qualified electors within the Community Facilities District the propositions which are attached hereto as Exhibit “A”; and

WHEREAS, there has been presented to the City Council a certificate of the City Clerk canvassing the results of the election, a copy of which is attached hereto as Exhibit “B”;

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF RIVERSIDE AS FOLLOWS:

Section 1. Each of the above recitals is true and correct and is adopted by the legislative body of the Community Facilities District.

Section 2. Propositions A, B and C presented to the qualified electors of the Community Facilities District on September 7, 2021 were approved by more than two-thirds of the votes cast at the election held for the Community Facilities District, and each of Propositions A, B and C has carried. The City Council is hereby authorized to levy on the land within the Community Facilities District the special taxes described in Proposition B for the purposes described therein and to take the necessary steps to levy the special taxes authorized by Proposition B and to issue bonds in one or more series in an aggregate amount not to exceed \$5,500,000 specified in Proposition A.

Section 3. The City Clerk is hereby directed to record in the Office of the County Recorder within fifteen days of the date hereof a notice of special tax lien which Bond Counsel to the Community Facilities District shall prepare in the form required by Streets and Highways Code Section 3114.5.
