

## CITY OF RIVERSIDE NOTICE OF PUBLIC HEARING WILLIAMSON ACT LAND CONSERVATION CONTRACT

**YOU ARE HEREBY NOTIFIED** that the City Council of the City of Riverside will hold a Public Hearing regarding the following item:

CASE NUMBER P20-0523: Petition by Lurin Land, LLC to cancel Williamson Act Land Conservation Contract, Instrument Number 19064, for Assessor Parcel Number 266-100-025.

**APPLICANT: Lurin Land, LLC** 

LOCATION: 18875 Lurin Avenue, on the south

side of Indiana Avenue, located at the southeast corner of Lurin Avenue and Obsidian Drive, in

Ward 4.

**PROPOSAL:** A Resolution will be considered to approve the petition for a Tentative Cancellation of a Williamson Act Land Conservation Contract. The subject property is approximately 10.06 acres and lies within the Woodcrest Agricultural Preserve No. 3 and is subject to a Williamson Act Land Conservation Contract. The Orangecrest Specific Plan provides that once the Williamson Act Land Conservation Contract is cancelled, and the Agriculture Preserve is diminished and terminated, the property reverts to the R-1-13000 Single-Family Residential Zone.

**ENVIRONMENTAL DETERMINATION:** A Mitigated Negative Declaration (MND) has been prepared for the alternative use and the cancellation of the Contract, and the Planning Commission considered the MND and alternative use at its July 22, 2021, meeting and approved the alternative use of a planned residential development consisting of 41 single-family residential lots.
