SUBJECT: NATIONAL LIBRARY CARD SIGN-IP MONTH

## **ISSUE:**

Receive an informational report on National Library Card Sign-Up Month.

#### **RECOMMENDATIONS:**

That the Board of Library Trustees receive an informational report on National Library Card Sign-Up Month.

#### **BACKGROUND:**

The Library Card Sign-up Month campaign began in 1987 by the American Library Association and the National Commission on Libraries and Information Science.

#### **DISCUSSION:**

September is National Library Card Sign-Up Month. The American Library Association has announced this year's Honorary Chair is Marley Dias. Signing up for a library card is the first step on the path towards academic achievement and lifelong learning. The Riverside Public Library had 11,770 new library card holders in January through December 2019 and 4,111 in January through December 2020.

Digital Library Cards can be obtained online at RiversideCA.gov/Library or in-person at any library facility.

On September 7, 2021, at the City Council meeting, Mayor proclaimed September as Library Card Sign-Up Month in the City of Riverside and encouraged everyone to sign up for their own library today.
