BACKGROUND

- 1. Public Works (PW) Bid No. 7852 for La Sierra Neighborhood Sidewalk Improvements
- 2. Project consists of the installation of new sidewalks in the La Sierra Neighborhood
- 3. Riverside Public Utilities (RPU) in collaboration with the Public Works Department is tasked to install new streetlight standards and associated underground facilities
- 4. Aligns with Envision Riverside 2025 Strategic Plan and City-wide Streetlight LED Conversion Program

PROJECT LOCATION

- Norwood Avenue, between Sierra Vista Avenue and College Avenue
- Doverwood Avenue, between Sierra Vista Avenue and La Sierra Avenue
- 3. Electric service disruptions will be coordinated to minimize impact to customers

RPU SCOPE OF WORK

- 1. Install the following:
 - a. 16 new concrete streetlight standards and related streetlight equipment
 - b. 3,650 feet of underground conduit
 - c. 4,300 circuit feet of secondary underground cable
 - d. 19 pull-boxes and other associated equipment
- 2. 4 weeks to complete work





BENEFITS

- Improves safety in the La Sierra Neighborhood
 - a. New sidewalks provide safer walkways for pedestrians and students
 - b. Improves street lighting in the area
- 2. Improves lighting system reliability
- 3. Improves system operations and safety

- Approve the Streetlight Installation component of Public Works Bid No. 7852 for La Sierra Neighborhood Sidewalk Improvements Project with LC Paving & Sealing, Inc., of Escondido, California in the amount of \$291,419.11;
- 2. Approve the capital expenditure for Work Order No. 1926828 in the amount of \$347,000 which includes all design, construction, construction support, contract administration, inspection and construction change order authority costs for the Streetlight Installation Component of Public Works Bid No. 7852 for La Sierra Neighborhood Sidewalk Improvements Project; and
- 3. Authorize the City Manager, or designee, to execute any documents necessary to effectuate the project described herein, as well as the ability to make minor non-substantive changes in alignment with all purchasing policies.
