
The People are demanding the Termination on the Execution of Judgment of Punishment on People of Color by Police Officers

## THE CURRENT ONE-SIZE FITS ALL POLICING MODEL IS INADEQUATE TO ADDRESS THE COMPLEXITIES OF ALL SOCIAL ISSUES

The Riverside Police Department has been utilizing peace keeping and protective policing practices for social welfare incidences.

Police Officers are being dispatched to handle social issues of mental health, homelessness, child protection/adult protection, and other social welfare issues.

Social Workers are bound by an ethic which states-Never practice beyond their scope of competency, but Police Officers are trained to work beyond their scope.

Police Officers are left to use peace tactics to solve social & mental health issues. (Walter Wallace)

When Police Officers are dispatched to handle someone with a mental health disorder, they respond by utilizing what they are trained to do. Use Physical Force.

911 is bombarded with repeat calls because citizens are not linked to social assistance which will help them to solve the underlining issues.

Disproportionate Amounts of Criminal records for minorities instead of the much-needed services to our most vulnerable population.

## 911 Calls - Community Social Worker (Policing)

9-1-1 is the most popular telephone number in the US and police are usually the first to answer the call. Thus, responding to crisis situations may require some social work skills, especially as "fifty to ninety percent of a police officer's time is allocated to gathering information and providing social service referrals."

### It is inevitable

CA Senator Nancy Skinner, introduced AB 773 in June 2020 and its "intent of the Legislature to enact legislation that would revise 911 systems so when an incident involves an issue of mental health, homelessness, and public welfare, the calls are directed to the appropriate social services agency" (<a href="https://leginfo.legislature.ca.gov/">https://leginfo.legislature.ca.gov/</a>).

# THE RAPID INTEGRATED GROUP HEALTHCARE TEAM (RIGHT) CARE PROGRAMDALLAS, TEXAS

- "RIGHT Care is a partnership involving specially-trained paramedics from Dallas Fire-Rescue, Dallas Police Department officers and Parkland behavioral health social workers." Funds provided by a three-year grant" (Parkland Hospital, 2019).
- "The RIGHT Care team responded to more than 2,500 mental health emergency 911 calls 2018. Due to the response of the RIGHT Care Program, there was a nearly 10 percent decline in Parkland's Psych ED volumes from ZIP codes served by RIGHT Care. The program diverted 31 percent of the calls they responded to from jails and hospital ERs by connecting patients to the resources in their community" (Parkland Hospital, 2019).

### **RIGHT CARE-Dallas Texas**

### Arrest Drop by 8% - RIGHT Calls only led to 2% Arrest

"The data shows the progress: Between pre-launch and 2019, admittance to the ER decreased by 9% in the targeted zip codes, while it increased in the rest of the city. Arrests dropped by 8%, while they went up in neighboring ones of a similar socioeconomic status. Just 2% of the RIGHT Care calls led to arrests, and the repeat call rate is less than 7%".

"Dallas Fire Rescue figures from 2016 show Community Paramedics posted an 82% reduction in 911 calls from the patients they visited at home".

### **CAHOOTS**


(Crisis Assistance Helping Out On The Streets) as a community policing initiative in 1989

A November 2016 study published in the American Journal of Preventative Medicine estimated that 20% to 50% of fatal encounters with law enforcement involved an individual with a mental illness. The CAHOOTS model demonstrates that these fatal encounters are not inevitable. Last year, out of a total of roughly 24,000 CAHOOTS calls, police backup was requested only 150 times.

The cost savings are considerable. The CAHOOTS program budget is about \$2.1 million annually, while the combined annual budgets for the Eugene and Springfield police departments are \$90 million. In 2017, the CAHOOTS teams answered 17% of the Eugene Police Department's overall call volume. The program saves the city of Eugene an estimated \$8.5 million in public safety spending annually.

## JUVENILE JUSTICE MOBILE RESPONSE TEAM

• "First, the results highlight the importance of applying the risk-need-responsivity model at the earliest point possible, as the screening conducted by JJMRT before youth were officially arrested resulted in the discontinuation of about a quarter of youth arrests and in turn allowed for the avoidance of formal processing. Second, a growing body of research argued for the inclusion of **social workers** in the juvenile justice process creates positive outcomes such as with JJMRT."

**Problem Statement:** Riverside Police Department is and has been utilizing policing practices inappropriately for the social welfare incidences. Policing practices have resulted in excessive use of force, sometimes unto death. Criminal arrests for those who would have benefited from an educated and trained mental health or social work professional.

**Goals:** Reduce the disproportionality of arrest of minorities and eliminate excessive use of force from Riverside PD by dispatching Social Workers to social welfare calls that do not require police officers.

#### Rationale:

Research states that excessive use of police force was the largest accounted for deaths amongst Black and Latino males.

Social workers and mental health professional have a broad skill set to effectively intervene in non-emergency police situations

#### **Assumptions:**

Civilian response model will help reduce repeated arrest.

Create positive community policing in communities of color.

Increase collaboration with police department, mental health professionals, and community-based organizations.
