BACKGROUND

- 1. A rifle attack occurred on PG&E Metcalf Subtransmission Substation in 2013
 - a) The attack resulted in damage to 17 transformers and repair costs totaling over \$15M
- 2. SB-699 (Jerry Hill) amended the Public Utilities Code and requires the California Public Utilities Commission (CPUC) to develop rules for addressing the physical security risks to the distribution systems



BACKGROUND

- 3. In response to Senate Bill (SB-699), CPUC issued Decision 19-01-018 requiring both investor-owned utilities and publicly-owned utilities to develop and implement plans to mitigate physical attacks on certain electrical distribution systems
- 4. RPU prepared a utility security plan to be in compliance with CPUC D.19-01-018

DISCUSSION

- 1. The Plan evaluates RPU's electrical distribution system against seven screening factors to determine if there are high priority facilities with regional implications
- 2. Based on these screening criteria, four substations are identified and are included in the plan
- 3. The decision requires a qualified third-party to conduct an independent review of RPU's Plan
- 4. RPU selected AESI-US Inc. as its third-party reviewer

DISCUSSION

- 5. AESI completed a comprehensive review of this Plan, including a review of the risk assessment principles and mitigation strategies
- 6. AESI found the Plan to be comprehensive and satisfies the CPUC Decision requirements
- 7. To include the local perspective and expertise, RPU sought the review of the Riverside Police Department (RPD), as a qualified authority to provide an additional level of review
- 8. RPU collaborates with RPD on public safety matters, and based on their review, RPD found the draft Plan to be adequate.

DISCUSSION

- 9. The risk assessment conducted for the four covered substations does not indicate any case of high risk requiring implementing a capital improvement project to correct a significant deficiency of the physical security in these facilities.
- 10. There are some mid-risk type conditions that will be improved to reduce the risk, such as improving the lighting system in some areas inside the substations, installing additional cameras, and improving vegetation management.

- 2. Authorize the City Manager, or his designee, to file with the California Public Utilities Commission a written Notice of Adoption of Final Security Plan.
