MINUTES

Chair Nelson convened the Board of Ethics meeting at 5:06 p.m.

ORAL COMMUNICATIONS FROM THE AUDIENCE

There was no one wishing to speak.

MINUTES

Following discussion, it was moved by Member Huerta and seconded by Member Newman to approve the minutes of August 5, 2021, as presented. The motion carried with Vice Chair Stahovich and Member Foley abstaining.

EXCUSAL OF ABSENCE

Following discussion, it was moved by Member Huerta and seconded by Member Keen by to excuse the absence of Vice Chair Stahovich and Member Foley from the meeting of August 5, 2021. The motion carried with Vice Chair Stahovich and Member Foley abstaining.

USE OF OUTSIDE LEGAL COUNSEL IN LIEU OF THE CITY ATTORNEY

Following discussion, it was moved by Member Huerta and seconded Vice Chair Stahovich that the Board of Ethics use outside legal counsel to advise the Board of Ethics and its hearing panel on the City Council v Councilmember Conder complaint. The motion carried unanimously.

Following further discussion, it was moved by Vice Chair Stahovich and seconded Member Huerta requesting outside counsel address the following questions regarding the Brown Act and for transparency purposes: (1) should the City Council have approved the complaint on a published agenda and during an open City Council Meeting(a) the complaint against Councilmember Conder

before it was accepted by the City Clerk?; (b) the completion of the complaint form by the City Council before it was submitted?; and, (c) subsequent actions including the random drawing for the hearing panel members?, (2) should have the pre-hearing been published as a joint meeting?; and (3) clarification of Riverside Municipal Code Section 2.80.040 (B)(3)(h) as to whether or not the complaint language refers only to the subject of the complaint or does it refer to any councilmember or members that might be a part of the complaint process to be disqualified from participating on the hearing panel? The motion carried unanimously.

Following further discussion, it was moved by Member Huerta and seconded Member Foley requesting an item be placed on the discussion agenda regarding authority and conditions in which to hire outside counsel for future Board meetings. The motion carried unanimously.

BOARD OF ETHICS PRE-HEARING CONFERENCE PROCESS OVERVIEW

Assistant City Attorney Wilson presented training on ethics pre-hearing conference process. No formal action was required or taken.

REPORT OF MEETINGS AND ACTIVITIES BY BOARD MEMBERS

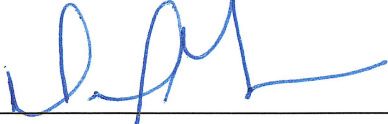
There was nothing to report on meetings and activities by Board Members.
