

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA AUTHORIZING THE CITY MANAGER TO EXECUTE THE
4 STANDARD AGREEMENT CONTRACT WITH THE CALIFORNIA
5 DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL FOR THE
6 ALCOHOL POLICING PARTNERSHIP PROGRAM (APP),

7 WHEREAS, the City of Riverside, by and through the Riverside Police Department ("RPD"),
8 desires to undertake IMPACT inspections, Minor Decoy, Trap Door, Shoulder Tap operations,
9 conduct surveillance and investigations of criminal activity in and around licensed premises, and train
10 RPD officers and the community (LEADS training) in prevention and enforcement measures in
11 collaboration with the Department of Alcoholic Beverage Control investigators, to be funded in part
12 from funds made available through the Alcohol Policing Partnership Program (APP) administered by
13 the Department of Alcoholic Beverage Control ("ABC").

14 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
15 California, as follows:

16 Section 1: That the City Manager of the City of Riverside, or his or her designee, is authorized
17 to execute on behalf of the City Council the Standard Agreement contract ("Contract") which is hereto
18 attached as Attachment "A", and any extensions or amendments thereof and any subsequent contract
19 with the State of California in relation thereto.

20 Section 2: Any liability arising out of the performance of the Contract, including civil court
21 actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The
22 State of California and ABC disclaim responsibility for any such liability.

23 Section 3: Grant funds received hereunder shall not be used to supplant expenditures controlled
24 by this body.

25 Section 4: This award shall not be subject to local hiring freezes.
