## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING THE LAND USE DESIGNATION OF THE RIVERSIDE GENERAL PLAN 2025 TO ACCOMMODATE FUTURE RESIDENTIAL AND MIXED-USE DEVELOPMENT CONSISTENT WITH THE 6<sup>TH</sup> CYCLE 2021-2029 HOUSING ELEMENT UPDATE.

WHEREAS, the Planning Commission of the City of Riverside, California, advertised for and held a public hearing on September 9, 2021, to consider the General Plan Amendment and recommended to the City Council that the General Plan Amendment be approved; and

WHEREAS, the City Council of the City of Riverside advertised and held a public hearing on October 5, 2021, to consider Planning Case No. PR-2021-001058; and

WHEREAS, the City Council received and considered the reports and recommendation from the Planning Commission and all other testimony, whether written or oral, presented at the public hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

<u>Section 1:</u> The above recitals are hereby incorporated as if set forth herein in full.

Section 2: It is in the public interest to amend the Land Use Designation of the Riverside General Plan 2025 as more particularly described below.

Section 3: The Land Use Designation of the Riverside General Plan 2025 is hereby amended by placing the properties listed in Exhibit "A" from their current land use designation to a new land use designation, all as more particularly described and depicted in Exhibit "A" attached hereto and incorporated herein by this reference.

<u>Section 4</u>: The Community & Economic Development Director is directed to make the changes to the Land Use Designation of the Riverside General Plan 2025 to conform to Exhibit "A."

Section 5: An Environmental Impact Report was prepared in connection with this action and has been certified concurrently with this action.
