A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A TIMED NO PARKING ZONE ON WILDERNESS AVENUE.

WHEREAS, the Public Works Department received a request from one hundred percent (100%) of the two (2) immediately impacted businesses on Wilderness Avenue from Ed Perkic Street to the northerly terminus requesting establishment of a "No Parking between the hours of 4:00 p.m. to 8:00 a.m. Daily" zone within this street segment; and

WHEREAS, businesses indicate that parking beginning in the early evening hours and
 extending overnight until early morning hours is unrelated to their business operations and is
 generating loitering, theft, and vandalism activities on their properties and dumping within the
 street and public right-of-way areas; and

WHEREAS, the Riverside Police Department has recommended establishment of the proposed Timed No Parking zone to restrict parking to deter illegal activity, loitering, trespassing, theft, illegal dumping, and overnight parking for the intent of accessing the Santa Ana River bottom located to the north end of Wilderness Avenue; and

WHEREAS, on August 4, 2021, the Transportation Board was cancelled by the Board
Chairman due to lack of quorum and to avoid delays in the processing of this request, the item has
been taken directly to City Council for consideration.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
California, as follows:

Section 1: The recitals set forth above are incorporated herein by reference.

<u>Section 2</u>: That the Master Parking Schedule is hereby amended by establishing a "No
Parking between the hours of 4:00 p.m. to 8:00 a.m. Daily" zone on both sides of Wilderness
Avenue from Ed Perkic Street to the northerly terminus.

26 <u>Section 3</u>: That the provisions of this resolution shall be operative only when signs are
27 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
28 limitations or prohibitions herein established.
