SUBJECT: UPDATE ON THE ANNUAL FIRE PREVENTION (WEED ABATEMENT)

PROGRAM

ISSUE:

Provide an update on the Parks, Recreation and Community Services Department's annual Fire Prevention program.

RECOMMENDATION:

That the Park and Recreation Commission provide feedback on the annual Fire Prevention program currently ongoing throughout the City of Riverside; and receive the report for file.

BACKGROUND:

The Parks Division provides an annual update to Park and Recreation Commission on the ongoing Fire prevention program, which uses mechanical, chemical, and physical methods to create firebreaks to minimize the risk and spread of wildfires near parks and open spaces throughout the City of Riverside.

In past years, the Parks Division has utilized crews from Cal Fire Crews to assist with these responsibilities so Parks Division Staff can continue their day-to-day duties. Due to COVID-19 restrictions, Cal Fire Crews and California Conservation Corps' participation has been halted; therefore, the Parks Division has had to use Parks Staff, Parks/PSET Staff, and contractors to create and maintain the firebreak areas throughout the City of Riverside.

DISCUSSION:

Since January 1, 2019 there have been 19 fires within Sycamore Canyon and approximately 700 acres have burned. Major concerns for the Riverside Fire Department at this time is the presence of Santa Ana Wind Conditions over 30 mph, the biggest threat being to the homes east of Canyon Crest Drive, off of Lochmor, and to the South in Santa Ana Wind Conditions to the Mission Grove Neighborhood, as well as the Mission Grove Neighborhood South of the Gas Line Road near Canyon Crest Drive.

The Parks Division has continued to create firebreaks in those areas to assist with keeping fuel (dry grass and weeds) cut back and creating fire breaks in those areas to date.

The maps attached are examples of sites where the Parks Division performs Fire Prevention maintenance. Staff performs handwork (132 acres), mowing (360 acres) and chemical application (119 acres) at 15 sites annually.
