SOFTWARE AND TECHNICAL SUPPORT SERVICES FOR PLANT CONTROL SYSTEMS - RIVERSIDE ENERGY RESOURCE CENTER AND SPRINGS GENERATING STATION

The Board of Public Utilities recommended that the City Council (1) authorize the expenditure for software and technical support services from E&M Electric & Machinery Inc., dba Wonderware, Healdsburg, California, for the plant control systems at Riverside Energy Resource Center and Springs Generating Station, for a two-year term in the amount of \$63,090; (2) approve the End User License Agreement with Aveva Software, LLC, for Wonderware Software; and (3) authorize the City Manager, or his designee, to execute the end user license agreement with Aveva Software, LLC including minor non-substantive changes.

AGREEMENT - ACQUISITION OF TEMPORARY CONSTRUCTION EASEMENT - PANORAMA ROAD AND UNION PACIFIC RAILROAD TRACKS

The Board of Public Utilities recommended that City Council (1) approve the Agreement with Riverside County Transportation Commission for Acquisition of a Temporary Construction Easement to extend the current Temporary Construction Easement for an additional nine-month for Assessor's Parcel Numbers 219-182-006, 219-182-007, and 219-182-016 located near the intersection of Panorama Road and the Union Pacific Railroad tracks for a total revenue of \$33,771; (2) approve the Agreement for Acquisition of a Temporary Construction Easement to extend the current Temporary Construction Easement for an additional nine-month term for Assessor's Parcel Numbers 219-103-019 and 219-182-012 located near the intersection of Panorama Road and the Union Pacific Railroad tracks for a total revenue of \$4,354; and (3) authorize the City Manager, or his designee, to execute the two agreements, including making minor non-substantive changes, and to sign all documents and instruments necessary to complete the transactions.

AGREEMENT - RFP 2074 - ELECTRIC COST OF SERVICES AND ANALYSIS AND RATE DESIGN Following discussion, it was moved by Member Cherney and seconded by Member Ocequera to (1) approve the Professional Consultant Services Agreement from Request for Proposal (RFP) 2074 for electric cost of service analysis and rate design with NewGen Strategies and Solutions, LLC., for a term through December 31, 2023; and (2) authorize the City Manager, or his designee, to execute the optional two-year contract extension. The motion carried unanimously.

#### 2021 RIVERSIDE PUBLIC UTILITIES WILDFIRE MITIGATION PLAN

Following discussion, it was moved by Member Crohn and seconded by Member Montgomery to recommend that the City Council (1) approve the 2021 Riverside Public Utilities Wildfire Mitigation Plan, Version 2 update in accordance with California Public Utilities Code Section 8387 for submittal to the Wildfire Safety Advisory Board; and (2) authorize the City Manager, or his designee, to submit the 2021 Riverside Public Utilities Wildfire Mitigation Plan, Version 2 update to the Wildfire Safety Advisory Board. The motion carried unanimously.

AGREEMENT - WORK ORDER 2124793 - BACKUP GENERATOR AND RELATED EQUIPMENT -CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES FISCAL YEAR 2020 COMMUNITY POWER RESILIENCY ALLOCATION TO CITIES PROGRAM - RAUB 6 GROUNDWATER WELL BACKUP GENERATOR INSTALLATION PROJECT

Following discussion, it was moved by Member Oceguera and seconded by Member Crohn to (1) authorize the purchase of a backup generator and related equipment from Cummins, Inc., under the Sourcewell Cooperative Agreement 120617-CMM, in the amount of \$117,502; (2) approve the capital expenditure for Work Order 2124793 in the amount of \$393,000 which includes all materials, design, construction, construction support, contract administration, inspection and construction change order authority costs for the Raub 6 Groundwater Well Backup Generator Installation Project; (3) authorize the City Manager to execute any documents necessary to effectuate this project, as well as the ability to make minor nonsubstantive changes in alignment with all purchasing policies; and (4) recommend that the City Council by at least five affirmative votes, waive the City Charter Section 1109 and authorize the Purchasing Manager to award a construction contract for the Raub 6 Groundwater Well site modifications to the lowest responsive and responsible bidder for RPU Bid 7867, in an amount not to exceed \$200,000, which includes construction contingency. The motion carried unanimously.
