SUBJECT: PRESENTATION ON THE BROWN ACT - CALIFORNIA'S OPEN MEETING LAW

ISSUES:

That Board of Ethics receive and file a presentation from the City Attorney's Office on the Brown Act, also known as California's Open Meeting Law.

RECOMMENDATIONS:

That the Board of Ethics receive and file a presentation from the City Attorney's Office on the Brown Act, also known as California's Open Meeting Law.

BACKGROUND:

The Brown Act was enacted in 1953 and is codified in the California Government Code, section 54950, <u>et seq</u>. In general, the Brown Act requires the deliberations and actions of California's public agency governing boards, commissions and councils be taken openly and in public.

The City Attorney's Office has prepared a presentation to present to the Board reviewing the requirements of the Brown Act, also known as California's Open Meeting Law.

- 5. **Sustainability & Resiliency** A presentation to the Board of Ethics on the Brown Act, also known as California's Open Meeting Law, ensures that the public is informed that the City of Riverside is committed to meeting the needs of the present without compromising the needs of the future and ensuring the City of Riverside's capacity to persevere, adapt and grow during good and difficult times alike.
