SUBJECT: PRESENTATION ON THE BROWN ACT - CALIFORNIA'S OPEN MEETING LAW

ISSUES:

That the Board of Public Utilities receive and file a presentation from the City Attorney's Office on the Brown Act, also known as California's Open Meeting Law.

RECOMMENDATIONS:

That the Board of Public Utilities receive and file a presentation from the City Attorney's Office on the Brown Act, also known as California's Open Meeting Law.

DISCUSSION:

The Brown Act was enacted in 1953 and is codified in the California Government Code, section 54950, <u>et seq</u>. In general, the Brown Act requires the deliberations and actions of California's public agency governing boards, commissions and councils be taken openly and in public.

The City Attorney's Office has prepared a presentation to present to the Board of Public Utilities reviewing the requirements of the Brown Act, also known as California's Open Meeting Law.
