

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE  
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A  
5 PREFERENTIAL PARKING ZONE ON BUTTERFIELD ROAD.

6 WHEREAS, the Public Works Department received a petition showing support from  
7 86% of residents on the west side of Butterfield Road from Lincoln Avenue to Calle La Cuesta  
8 requesting establishment of a combined 2-Hr. and Timed No Parking Preferential Parking Zone  
9 (“PPZ”).

10 WHEREAS, residents in close proximity to the recently constructed apartment complex  
11 on nearby Lincoln Avenue indicate that overflow parking from the apartment complex is limiting  
12 the availability of on-street parking opportunities near their homes, impacting ingress and egress  
13 from their properties due to residents of the apartments and guests parking close to or blocking  
14 residential driveways, and causing issues with mail delivery and trash can placement; and

15 WHEREAS, residents have also reported additional noise in late evening and early  
16 morning hours associated with the additional demand for on-street parking generated by the new  
17 apartment complex; and

18 WHEREAS, the establishment of the PPZ’s would provide short-term 2-Hr. parking  
19 opportunities for apartment complex tenants and guests between the hours of 8:00 a.m. to 8:00  
20 p.m.; and

21 WHEREAS, on October 6, 2021, the Transportation Board approved staff’s  
22 recommendation to establish a Preferential Parking Zone on the designated segment of Butterfield  
23 Road.

24 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
25 California, as follows:

26 Section 1: The recitals set forth above are incorporated herein by reference.

27 Section 2: That the Master Parking Schedule is hereby amended by establishing a “2-  
28 Hour Parking between the hours of 8:00 a.m. to 8:00 p.m. and No Parking between the hours of

1 8:00 p.m. to 8:00 a.m. Daily, with Preferential Permit Parking for residents” zone on the west side  
2 of Butterfield Road from Lincoln Avenue to Calle La Cuesta.

3 Section 3: That the provisions of this resolution shall be operative only when signs are  
4 erected on that portion of the street set forth in Section 2 above, giving notice of the parking  
5 limitations or prohibitions herein established.

6 Section 4: The provisions of this amendment shall be operative as of the date of adoption  
7 of this resolution.
