A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A PREFERENTIAL PARKING ZONE ON LINCOLN AVENUE.

WHEREAS, the Public Works Department received a petition showing support from 86% of residents on the south side of Lincoln Avenue from Van Buren Boulevard to Loyola Street and the north side of Lincoln Avenue from 315 feet west of Van Buren Boulevard to Loyola Street requesting establishment of a combined 2-Hr. and Timed No Parking Preferential Parking Zone ("PPZ's").

WHEREAS, residents in close proximity to the recently constructed apartment complex on Lincoln Avenue indicate that overflow parking from the apartment complex is limiting the availability of on-street parking opportunities near their homes, impacting ingress and egress from their properties due to residents of the apartments and guests parking close to or blocking residential driveways, and causing issues with mail delivery and trash can placement; and

WHEREAS, residents have also reported additional noise in late evening and early morning hours associated with the additional demand for on-street parking; and

WHEREAS, the establishment of the PPZ's would provide short-term 2-Hr. parking opportunities for apartment complex tenants and guests between the hours of 8:00 a.m. to 8:00 p.m.; and

WHEREAS, on October 6, 2021, the Transportation Board approved staff's recommendation to establish Preferential Parking Zones on designated segments of Lincoln Avenue.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

<u>Section 1</u>: The recitals set forth above are incorporated herein by reference.

Section 2: That the Master Parking Schedule is hereby amended by establishing a "2-Hour Parking between the hours of 8:00 a.m. to 8:00 p.m. and No Parking between the hours of 8:00 p.m. to 8:00 a.m. Daily, with Preferential Permit Parking for residents" zone on the south

1	side of Lincoln Avenue from Van Buren Boulevard to Loyola Street and the north side of Lincoln
2	Avenue from 315 feet west of Van Buren Boulevard to Loyola Street.
3	Section 3: That the provisions of this resolution shall be operative only when signs are
4	erected on that portion of the street set forth in Section 2 above, giving notice of the parking
5	limitations or prohibitions herein established.
6	Section 4: The provisions of this amendment shall be operative as of the date of adoption
7	of this resolution.
