**APPROVAL OF MINUTES**

Motion was made by Member Alderette and seconded by Member Carrillo approving the July 7, 2021 Transportation Board meeting minutes as presented.

**CHALLEN STREET AT ORLANDO DRIVE & FOOTHILL AVENUE – TEMPORARY NEIGHBORHOOD TRAFFIC CIRCLE PILOT PROJECT**

Following discussion motion was made by Vice Chair Bullock and seconded by Member Bulinski recommending that the Transportation Board recommend that the City Council approve a 6-month temporary Neighborhood Traffic Circle improvement pilot project at the intersection of Challen Street and Orlando Drive / Foothill Avenue.

Motion carried unanimously.

**EXTENSION OF TEMPORARY PARKING CONSIDERATION FOR THE RIVERSIDE COUNTY OFFICE OF EDUCATION - SUSPENSION OF ENFORCEMENT OF SURROUNDING 90-MINUTE TIME LIMIT AND PREFERENTIAL PARKING ZONES, PASSENGER LOADING ZONE, AND PREPAY METERED PARKING THROUGH MARCH 2022**

Following discussion motion was made by Vice Chair Bullock and seconded by Member Carrillo that the Transportation Board recommend to the City Council regarding Riverside County Office of Education (RCOE) requests for:

1. Extension of the suspension of enforcement of 90-Minute Timed and white curb passenger loading zone on 13<sup>th</sup> St. between Brockton Ave. and Chestnut St.; the 90-

Minute Preferential Parking Zone on the south side of 12<sup>th</sup> St. between Chestnut St. and Almond St. from July 1, 2021 through March 31, 2022.; and

2. Authorization to intermittently prepay metered spaces at the full rate of \$1.50/hour per space, without reserving the spaces but withhold enforcement, as requested, at these locations:
  - a. Both sides of Almond St. between 11<sup>th</sup> and 12<sup>th</sup> Streets; and
  - b. Southside of 12<sup>th</sup> St. from Almond St. until the driveway approach.

Motion carried unanimously.

### **INDIANA AVENUE – ESTABLISHMENT OF TIMED NO PARKING ZONE**

Following discussion motion was made by Member Bulinski and seconded by Member Martin recommending that the Transportation Board recommend that the City Council approve establishment of a “No Parking between the hours of 7:00 to 9:00 a.m. and 4:00 to 6:00 p.m. Monday through Friday except holidays” zone on the south side of Indiana Avenue from Wickham Drive to 375 feet easterly thereof.

Motion carried unanimously.

### **MARKET STREET AND SIXTH STREET – TRAFFIC CIRCULATION PILOT PROJECT**

Following discussion motion was made by Member Carrillo and seconded by Member Martin recommending that the Transportation Board recommend that the City Council approve a 1-month traffic circulation pilot project to prohibit through and left-turn movements at the eastbound and westbound approaches of the intersection of Market and Sixth Streets.

Motion carried unanimously.
