1 RESOLUTION NO. 2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE 3 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A TIMED NO PARKING ZONE ON INDIANA AVENUE. 4 WHEREAS, the Public Works Department is proposing the establishment of a Timed No 5 Parking zone on the south side of Indiana Avenue from Wickham Drive to 375 feet easterly 6 thereof in conjunction with an upcoming roadway repaying project which will include installation of a Class II Bike Lane within this segment of roadway; and 8 WHEREAS, the new Class II Bike Lane will connect to existing facilities on Indiana 9 Avenue east of La Sierra Avenue and provide direct access to the nearby La Sierra Metrolink 10 station; and 11 WHEREAS, it is anticipated that cyclist activity during typical a.m. and p.m. commute 12 hours will increase due to the proximity to the La Sierra Metrolink Station; and 13 WHEREAS, the establishment of a timed no parking zone would preserve Class II Bike 14 Lane use during peak hours and facilitate cyclist access to the Metrolink Station; and 15 WHEREAS, on September 1, 2021, the Transportation Board unanimously approved 16 staff's recommendation to establish the time limited parking zone on the designated segment of 17 Indiana Avenue. 18 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, 19 California, as follows: 20 Section 1: The recitals set forth above are incorporated herein by reference. 2.1 Section 2: That the Master Parking Schedule is hereby amended by establishing "No 22 Parking between the hours of 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m. Monday through 23 Friday except holidays" zone on the south side of Indiana Avenue from Wickman Drive to 375 2.4 25 feet easterly thereof. Section 3: That the provisions of this resolution shall be operative only when signs are 26 erected on that portion of the street set forth in Section 2 above, giving notice of the parking 27 limitations or prohibitions herein established. 28

1	Section 4: The provisions of this amendment shall be operative as of the date of adoption
2	of this resolution.
