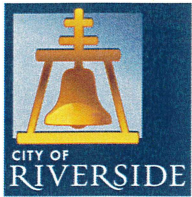

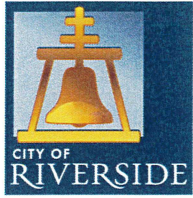
RESHAPE RIVERSIDE REDISTRICTING PROCESS UPDATE

Following discussion, it was moved by Chair Cervantes and seconded by Vice Chair Perry to (1) receive and order filed an update on the Reshape Riverside Redistricting Plan; (2) consider Community of Interest Testimony and Draft Redistricting Maps; and (3) direct Redistricting Partners and staff to (a) eliminate draft Map C, (b) provide draft maps with street and deviation information; and (c) prepare a map modifying Draft D keeping the Arlanza Neighborhood together. The motion carried unanimously.

ESTABLISH POLICY FOR PROPER DISPLAY AND HANDLING OF FLAGS AT CITY FACILITIES AND APPROVAL AND DISPLAY OF COMMEMORATIVE FLAGS

Following discussion, it was moved by Chair Cervantes and seconded by Vice Chair Perry to refer the Riverside Flag Policy to City Council in January 2023 for consideration. The motion carried with Chair Cervantes and Vice Chair Perry voting aye, and Member Conder voting no.
