Following discussion, it was moved by Vice Chair Edwards and seconded by Chair Fierro to (1) award of Request for Proposal 2203 for Sponsorship Asset Inventory, Valuation, Naming Rights and Sales to the Superlative Group, Inc., for a consultant retainer of \$317,625 and 15% commission on potential sales; (2) with at least five affirmative votes, authorize a supplemental appropriation in the amount of \$317,625 in the General fund, City Manager-Administration, Professional Services Account; and (3) authorize the City Manager, or designee, to execute the Professional Services Agreement, including execution of the optional extension for one six-month period and making minor and non-substantive changes as necessary. The motion carried with Chair Fierro and Vice Chair Edwards voting yes and Member Hemenway absent.

### FISCAL YEAR 2022-2023 CITY SPONSORSHIP PROGRAM THROUGH JUNE 30, 2023

Following discussion, it was moved by Member Hemenway and seconded by Vice Chair Edwards to (1) receive input on the criteria used by City Departments in evaluating City Sponsorship applications and directed staff to (a) include a column that states why a program was selected for the City Sponsorship Program for period of January 1, 2023 – June 30, 2023; and (b) explore offering a multi-year sponsorship program; and (2) recommend that City Council approve City Sponsorship support in the form of monetary funding and/or in-kind contributions of \$144,901 for charitable and community events. The motion carried unanimously.
