### CONSENT CALENDAR MINUTES


The minutes of February 22, 2023 were approved.

Manager Megan Stoye reported the following City Council items associated with RPD:

February 28, 2023:


- (1) Riverside Police will receive \$180,000 in overtime reimbursement for US Marshals Service Regional Fugitive Task Force participation from October 1, 2022 through September 30, 2023.

March 7, 2023

The Board of Administration California Public Employees' Retirement System and the City Council City of Riverside have agreed to implement a retirement cost-sharing provision of 5.5 percent of pensionable income for all classic, Tier 1 and Tier 2 Unrepresented Police Management employees, members of the Riverside Police Administrators' Association (RPAA) and cost sharing provisions of 4.5 percent of pensionable income for all class Tier 1 and Tier 2 members of the Riverside Police Officer's Association (RPOA) Supervisory.

March 14, 2023

- (1) Justice Assistance Grant (JAG) Program to receive a total of \$108,142 for salary and benefits of one Senior Forensic Specialist position for approximately nine

months with an amount of \$3,730 for overtime to implement National Incident-Based Reporting System (NIBRS) crime data-reporting program and training.

Manager Stoye notified Commissioners of interviews conducted by the City Council which will be taking place April 11, 2023 for the three vacant CPRC seats. The action item will secure commissioners to fill seats for wards 2, 3 and City-Wide seat. Manger Stoye reminded commissioners that The City Clerk's Office invites all members of Boards and Commissions to attend the Boards and Commissions Reception which will occur on April 12, 2023.

### ITEMS FOR FUTURE CONSIDERATION AS REQUESTED BY COMMISSION MEMBERS OR CPRC MANAGER

Commissioner DeBrier requested clarification regarding OID information, he would like to know if information would be provided in time for the April 2023 meeting. Manager Stoye clarified OID information would be provided in time for April 2023 meeting.

Frank Hauptmann reminded commissioners of two upcoming hands-on training opportunities: "Shoot-Don't-Shoot" simulator, and "pat-down" / "handcuff" procedures, which will allow commissioners to participate in. Riverside presentations on trainings will be deferred until May 2023.

Commissioner DeBrier requested clarification on dates for future items. Manager Megan Stoye informed commissioners they would be informed when there is an update for pending items, well as a brief update on the incident that occurred with PANS Officers.

The next meeting is scheduled for Wednesday, April 26, 2023.

Chair Berrellez adjourned the meeting at 7:31 p.m.
