PRESENTATION FROM RIVERSIDE UNIFIED SCHOOL DISTRICT

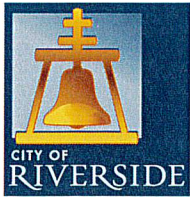

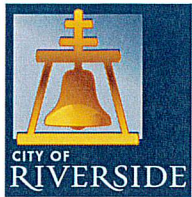
COMMUNICATIONS
