There was no one wishing to address the Committee.

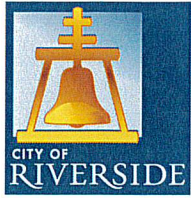
### PRESENTATION

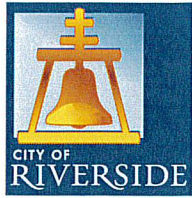
Commissioner Keller gave update on AARP Needs Assessment Survey
