BROWN ACT


City Attorney's Office Susan Wilson presented on the Brown Act.


Commissioners Lewis, German, Woods-Adeyeye and Goe volunteered to participate. No formal motion was taken.

ITEMS FOR FUTURE HUMAN RELATIONS COMMISSION CONSIDERATION


