this month. They expect to complete the work at the YMCA, the latest, December 2016 at which time the students at 5320 Victoria Avenue will be transferred to the permanent school site. Comments from the audience: Nishaat Ismailjee, resident behind the church, voiced her concerns regarding traffic, noise and safety, due to the existing church and schools in the neighborhood and the potential of a new school at the church site. Pam Buchan, resident, spoke regarding traffic impacts to the neighborhood. Seth Lorda, Mt. Rubidoux Executive Pastor, stated he has been working with River Springs Charter School and spoke regarding the benefits of having the River Springs Charter School at this location. Following discussion the Planning Commission recommended a continuance of Planning Case P15-0337 to the meeting of August 6, The Commission requested that the applicant meet with the residents so that they can hear the neighborhood's concerns and hopefully come to a resolution. It was also requested that a formal agreement with Temple Beth El for egress, be provided at the next meeting.

PLANNING CASES P15-0068, P15-0175, P15-0176, P15-0399 & P15-0400 - Conditional Use Permit, Design Review and Variance at 3695 Central Avenue

Proposal by Geoff Ingles of Galardi Group to consider a Conditional Use Permit, Design Review, and Variances related to the demolition of an existing drive-thru restaurant ("Wienerschnitzel") and the construction of a new drive-thru restaurant. Gayat Adame, Assistant Planner, presented the staff report. She called attention to the revised conditions distributed this morning. Mitch Adkison, Adkan Engineers, representing the applicant stated they were in agreement with the recommended conditions. There were no comments from the audience. Following discussion the Planning Commission recommended that the City Council: 1) Determine that the proposal is exempt from the California Environmental Quality Act (CEQA) review pursuant to Section 15332 (In-Fill Development); 2) Approve Planning Cases P15-0068, P15-0175, P15-0176, P15-0399 and P15-0400 based on the findings outlined in the staff report and subject to the revised recommended conditions.

Planning Cases P15-0265 & P15-0403 – revised Conditional Use Permit and Design Review -- 8172 Magnolia Avenue Proposal by Luke Robinson of Family Service Association to consider a revised Conditional Use Permit and Design Review to add two modular structures and increase the number of children from 144 to 200 at an existing daycare center ("YWCA"). 

Dom Betro, Family Service Association, asked the Commission to remove condition 4 and allow the structures to remain permanently. He stated that the modular structures are screened from the street. There were no comments from the audience. Following discussion the Planning Commission recommended that the City Council:  1) Determine that the proposal is exempt from the California Environmental Quality Act (CEQA) review pursuant to Section 15332 (In-Fill Development); 2) Approve Planning Cases P15-0265 and P15-0403 based on the findings outlined in the staff report and subject to the revised recommended conditions. The Commission did not agree with the applicant's request to remove condition 4. Commissioner Kain cited inefficiency of the building layout, aesthetic and overall sustainability issues with the modular structures. Over time the site could be a center of excellence and have permanent buildings that use the site efficiently.
