PUBLIC SAFETY COMMITTEE Tuesday, August 4, 2015, 9 a.m. **Art Pick Council Chamber**

Chair Perry called the meeting to order at 9 a.m.

DENIAL OF MASSAGE ESTABLISHMENT PERMIT - APPEAL - BLUE MOON **MASSAGE - 6969 BROCKTON AVENUE**

Following discussion, motion was made by Chair Perry and seconded by Member Burnard to deny the appeal of Blue Moon Massage based on the evidence presented. The denial is based on Section 5.52.050 of the Riverside Municipal Code and specifically, the following grounds:

- 1. The Appellant was arrested in June 2010 for violating California Penal Code section 653.23(A)(1), supervising prostitution, in the City of Costa Mesa.
- 2. The Appellant failed to disclose this information regarding the prior arrest on the application.
- The Appellant submitted false information on her application. 3.
- 4. The operation of the massage establishment by the Appellant will not comport with the peace, health, safety, convenience, good morals, and general welfare of the public.

Motion carried unanimously.

Chair Perry advised that pursuant to the vote, the Public Safety Committee is hereby denying the appeal of Blue Moon Massage. The decision of the Public Safety Committee is final with no further right of appeal to the City Council. Because there is no provision for reconsideration of the decision, or for a written decision or written findings supporting the decision in any applicable provision of any statute, charter, or rule, this decision is final today. The appellant may seek judicial review of the decision pursuant to California Code of Civil Procedure, section 1094.5 by filing a petition with the Riverside County Superior Court. The time within which judicial review must be sought is governed by Section 1094.6.

PROHIBITION OF CAMPING AND STORAGE OF PERSONAL PROPERTY ON PUBLIC STREETS, SIDEWALKS, AND PROPERTY - CONTINUED

Following discussion, motion was made by Chair Perry and seconded by Vice Chair Melendrez to continue the discussion regarding an amendment to the Riverside Municipal Code prohibiting camping and storage of personal property on public streets, sidewalks, and property. Motion carried unanimously.

ORAL COMMUNICATIONS FROM THE AUDIENCE

There were no oral communications at this time.

ITEMS FOR FUTURE PUBLIC SAFETY COMMITTEE CONSIDERATION AS REQUESTED BY MEMBERS OF THE COMMITTEE

Vice Chair Melendrez requested a report on guidelines for closure of businesses following denial or withdrawal of appeals for massage establishments within 30 days. Chair Perry requested discussion of a fireworks educational campaign on dangers, penalties, and enforcement actions to address illegal firework use.
