Chair Davis convened the meeting at 1 p.m.

RIVERSIDE COUNTY GENERAL PLAN AMENDMENT NO. 960 - REGIONAL TRANSPORTATION CORRIDORS

Following discussion, motion was made by Chair Davis and seconded by Member Melendrez recommending that the City Council request (1) the County of Riverside to maintain the Community and Environmental Transportation Acceptability Process (CETAP) Corridor parallel to Cajalco between I-215 and I-15 in the General Plan; (2) the County of Riverside to actively work towards a corridor to Orange County as an alternative to the 91 Freeway and preserve right-of-way to the greatest extent possible; and (3) Riverside County Transportation Commission (RCTC) to re-initiate the CETAP process between the 15 and 215 freeways and restart the previous environmental studies. Motion carried unanimously.

Member Melendrez left the meeting at this time and Councilmember Soubrious substituted for Member Melendrez for the following item only.

DECREASE PARKING VIOLATION FINES FOR BLOCKING DISABLED CURB CUT ACCESS - VIOLATION OF 22500(I) CALIFORNIA VEHICLE CODE

Following discussion, motion was made by Councilmember Soubrious and seconded by Vice Chair Mac Arthur recommending that the City Council (1) direct the City Attorney to prepare a resolution amending Resolution No. 22463 to (a) provide amendment to reduce the fine for violation of 22500(I) California Vehicle Code (CVC) from \$341 to \$41; and (b) clarify what constitutes a violation of 22500(I) CVC; and (2) authorize the City Manager, or his designee, to execute the necessary documents or training. Motion carried unanimously.
