PROP 84 INTEGRATED REGIONAL WATER MANAGEMENT (IRWM) PROGRAM 2014 DROUGHT SOLICITATION IMPLEMENTATION GRANT FUNDING CONTRACT BETWEEN THE SANTA ANA WATERSHED PROJECT AUTHORITY (SAWPA) AND CITY OF RIVERSIDE FOR \$107,515 TO \$215,030

Assistant General Manager Todd Jorgenson explained how RPU receives grant funding to study conservation-based or budget-based water rates and clarified that the funding may only be used on activities related to conservation-based water rate studies.
