

Gaby Adame, Assistant Planner, presented the staff report. Brian Coffman stated that the proposed lift at the facility would not have the acrylic panels shown in the staff report pictures. The rendering materials and design of the lift shall be subject to the Historic Preservation staff approval; thereby issuing a Certificate of Appropriateness for the project.
