


AGREEMENT AMENDMENT - SHARING HOUSEHOLDS ASSIST RIVERSIDE'S ENERGY PROGRAM The City Council (1) approved the Fifteenth Amendment to the Agreement with the County of Riverside Department of Public Social Services - Department of Community Action in the amount of \$1,000,000 to extend the Sharing Households Assist Riverside's Energy (SHARE) contract through June 30, 2016; and (2) authorized the City Manager, or his designee, to approve payments up to 25 percent, or \$250,000, above the SHARE contract amount if allocated funds are depleted before the contract term ends.

SUBLEASE AGREEMENT - MISSION SQUARE - 3750 UNIVERSITY - SUPPLEMENTAL APPROPRIATION Following discussion, the City Council (1) approved the Sublease Agreement with Gresham Savage for approximately 20,298 square feet of office space for \$411,035 annually in the Mission Square Building located at 3750 University Avenue; (2) authorized a supplemental appropriation in the amount of \$156,000 for the increase in rental expense to an account to be established by the Finance Department; (3) authorized a supplemental appropriation in the amount of \$125,000 for moving costs, furniture, fixtures, and equipment associated with the relocation of the City Attorney's Office from the fifth floor of City Hall to the second floor of the Mission Square Building to an account to be established by the Finance Department; and (4) authorized the City Manager, or his designee, to execute the Sublease Agreement, including making minor, non-substantive changes, and to sign all documents and instruments necessary to complete the transaction. <u>COMMUNICATIONS</u> CITY ATTORNEY REPORT ON CLOSED SESSIONS City Attorney Geuss announced there was nothing to report on the closed sessions held earlier in the day.
