TRANSPORTATION COMMITTEE City of Riverside Thursday, December 10, 2015, 1 p.m. Art Pick Council Chamber

Chair Davis convened the meeting at 1:01 p.m.

TRUCK ROUTES TECHNICAL ANALYSIS - PILOT PROGRAM

Following discussion, and without formal motion, the Committee unanimously requested to return the truck routes technical analysis and the pilot program to the Transportation Committee in April 2016 to allow for community meetings and further study on enforcement options.

PREFERENTIAL PARKING ZONE - HILLANDALE COURT

Following discussion, motion was made by Member Melendrez and seconded by Vice Chair Mac Arthur recommending that the City Council (1) approve changing the duration of the existing preferential parking zone on both sides of Hillandale Court from Goodrich Drive to the easterly terminus from "No Parking Between the Hours of 7:00 a.m. to 4:00 p.m. Monday through Friday, With Preferential Permit Parking for Residents" zone to "No Parking Any Time With Preferential Permit Parking for Residents" zone. Motion carried unanimously.

TIMED PARKING ZONES - FIFTH AND ORANGE STREETS

Following discussion, motion was made by Vice Chair Mac Arthur and seconded by Member Melendrez recommending that the City Council approve effective for school hours only the removal of (1) 2-Hour Parking Zone Between the Hours of 9:00 a.m. to 6:00 p.m. of Any Day Except Sunday and Holidays" zone on both sides of Fifth Street from Orange Street to Lemon Street from the Master Parking Schedule; (2) existing 20-Minute Parking Zone Between the Hours of 8:00 a.m. to 5:00 p.m. Except Saturday, Sunday, and Holidays" zone on the east side of Orange Street from Fifth Street to 143 feet northerly thereof; and (3) existing "2-Hour Parking Zone Between the Hours of 9:00 a.m. to 6:00 p.m. of Any Day Except Sunday and Holidays" zone on the east side of Orange Street from 143 feet north of Fifth Street to Third Street. Motion carried unanimously.

PREFERENTIAL PARKING ZONE - HOMEWOOD COURT

Following discussion, motion was made by Vice Chair Mac Arthur and seconded by Chair Davis recommending that the City Council approve a "No Parking Between the Hours of 8:00 a.m. to 4:00 p.m. Monday through Friday Except Holidays with Preferential Permit Parking for Residents" zone on both sides of Homewood Court from Brockton Avenue to the westerly terminus. Motion carried unanimously.

PREFERENTIAL PARKING ZONE - ABERNATHY DRIVE

Following discussion, motion was made by Member Melendrez and seconded by Vice Chair Mac Arthur recommending that the City Council approve a "No Parking Between the Hours of 6:00 p.m. to 8:00 a.m. Daily With Preferential Permit Parking for Residents" zone on both sides of Abernathy Drive from Fair Isle Drive (North) to Fair Isle Drive (South). Motion carried unanimously.

The Committee directed staff to present parking zone requests directly to the City Council without Committee review.

ORAL COMMUNICATIONS FROM THE AUDIENCE

Paul Chavez spoke regarding a Van Buren truck route and residential timed parking zones.
